## REGULAR COUNCIL MEETING CITY OF CROSSLAKE MONDAY, APRIL 13, 2009 7:00 P.M. – CITY HALL

The Council for the City of Crosslake met in the Council Chambers of City Hall on Monday, April 13, 2009. The following Council Members were present: Mayor Jay Andolshek, Steve Roe, John Moengen, Rusty Taubert and Dean Swanson. Also present were City Administrator Tom Swenson, Clerk/Treasurer Darlene Roach, Community Development Director Ken Anderson, Police Chief Bob Hartman, Public Works Director Ted Strand, Park and Recreation Director Jon Henke, General Manager Paul Hoge, City Attorney Mike Couri, City Engineer Dave Reese, Northland Press Reporter Paul Boblett and Echo Publishing Reporter Ken Korczak. There were approximately twelve individuals in the audience.

- A. CALL TO ORDER Mayor Andolshek called the Regular Council Meeting to order at 7:00 P.M. MOTION 04R-01-09 WAS MADE BY DEAN SWANSON AND SECONDED BY JAY ANDOLSHEK TO ACCEPT THE ADDITIONS TO THE AGENDA AS PRESENTED. MOTION CARRIED WITH ALL AYES.
- B. CRITICAL ISSUES Sheriff Todd Dahl addressed the Council and stated that the purpose of his attending the meeting was to answer any questions the Council may have pertaining to the Crow Wing County Sheriff's Department. He stated that a joint program is underway with the Crosslake Police Department, the Crow Wing County Sheriff's Department and Crow Wing County Triad where the senior population are being informed of various con games, trickery and identify theft situations where seniors are the targets. Dahl stated that society is changing where it no longer is advisable to leave doors unlocked and maintain the trust that previously was prevalent especially in this area. On June 3, 2009 from 1:00 p.m. -3:00 p.m. an informational meeting will be held at the Crosslake Community Center where senior citizens will be able to receive valuable help on what they can do to protect themselves from being a victim of fraud and crime. Dahl stated that he is currently in the process of distributing a quarterly report to all cities and townships which reflects the number of top ten calls responded to by the Sheriff's Department. In the report that was distributed to the Council for 1st Quarter 2009, traffic stops accounted for 288 calls, there were 190 alarms, 102 property damage accidents, 77 motorist assists, 76 reports of theft, 69 reports of suspicious activity, 66 noise complaints, 54 welfare checks, 53 driving complaints and 46 civil problems. Other calls not included in the top ten calls totaled 1,622 and included agency assists, transports, gun permits, alarm registrations and etc. Sheriff Dahl stated that as of this date there are 160 prisoners in the jail with 90 of these prisoners being Crow Wing County prisoners and the remainder being those housed at the facility from other counties who pay rent to the County for this service. Dahl stated that his main goal is to not see repeat offenders and hopes that the Christian based ministry program, AA program and other offerings which are available in house assist with this goal.

#### D. PUBLIC FORUM - None.

**E. MAYOR'S REPORT** – Carol Rassatt of the American Legion Auxiliary was present to remind everyone that May 8<sup>th</sup> and May 9<sup>th</sup> is Poppy Day in Crosslake and how the proceeds of these poppy sales assist local veterans. Mayor Andolshek read a proclamation declaring May 8<sup>th</sup> and May 9<sup>th</sup> as Poppy Days in Crosslake and urged citizens to wear a memorial poppy as a symbol of their deep appreciation for the services rendered our nation by these veterans.

Mayor Andolshek read a letter received April 1, 2009 from Pequot Lakes Superintendent Rick Linnell thanking the city employees for their diligent plowing of the streets during a difficult year for bus drivers. The employees prompt attention to snow removal made a difficult task much easier for these drivers.

This request is due to the discontinuance of coverage by the Brehm Group effective February 28, 2009 who previously offered coverage to all City Council and Board Members. The insurance through LMCIT is limited to only those boards or commissions who have statutory authority, therefore the other commission members are covered under the City's Volunteer Insurance Coverage which the City participates in through LMCIT. #### G. COMMISSION/DEPARTMENT REPORTS -

#### 1. PARK AND RECREATION/LIBRARY -

Park Director Jon Henke addressed the Council and stated that the minutes of the February 23, 2009 meeting of the Park and Recreation/Library Commission were included for Council information. In Henke's report to the Council he informed everyone that the Community Center is offering aerobics on Mondays, Tuesdays and Thursdays at 9:00 a.m. AAA is sponsoring a senior driving 4-hour refresher class on Thursday, May  $7^{th}$  from 12:00-4:00 p.m. and a full senior driving course on June  $3^{rd}$  and June  $4^{th}$  from 9:00 a.m. to 1:00 p.m. each day. The Community Center gym is reserved each weekday morning from 8:00 to 9:00 a.m. for walking, however the gym is also open for walking at various times during the day. The Library offers the Children's Story Hour that takes place on Thursday's at 10:30 a.m. and will offer a Summer Reading Club beginning July 9th and continuing each Thursday through August 13th. Participants will receive weekly rewards and free teeshirts as well as being entertained by special performers and guests including a storyteller and magician, a wild critter, horses and trains. A \$5 fee will pay for 6 mornings of fun. The Story Hour will be held from 9:00 -10:00 a.m. for Grades K-2 and 10:00 - 11:00 a.m. for Grades 3-5. A guest speaker, Barbara Doerring, will be at the Library on Monday, May 11th to talk about her nephew Greg Mortenson's work with the Central Asia Institute building schools in the world's most volatile war zone. A total of 78 schools have been built in Pakistan and Afghanistan in appreciation for the care given Mr. Mortenson when he was rescued back to health by people in a poor town in Pakistan when an attempt to climb the Karakorum Mountain Range failed. His promise to return to the region and fulfill a promise to repay the kindness is documented in the book "Three Cups of Tea". The Kitchigami Mobile Library makes its regular stop at the Community Center on the second and fourth Thursday of every month from 12:45 - 2:45 p.m. Starting on May 28<sup>th</sup>, the Library will have extended hours and will remain open each Thursday until 6:00 p.m. through Labor Day. Yoga is available at the Community Center on Monday nights from 5:15 to 6:45 P.M. and on Thursday mornings from 10:00 to 11:30 a.m. Senior meals take place at the Community Center Monday through Friday at 11:30 a.m. Interested participants must call by 4:00 p.m. the day before and make a reservation. Meals on wheels are also available for those residents who are home bound. Federal funding for this program is based on participation. Attendance for the Community Center for the month of March was 5,040 patrons and 2,328 for the Library. Volleyball is offered every Wednesday night from 6:30 to 8:45 p.m. A woodcarving group meets the second Tuesday of each month at 2:00 p.m. and residents who have an

interest in woodcarving are encouraged to attend. The Chautauqua Program for May will feature information about Elderhostel's. Several individuals who have attended Elderhostels will explain the variety, costs and benefits of these programs. The fitness room is open seven days a week for all those interested in utilizing the exercise equipment at the facility. Summer baseball registrations have been mailed to all participants from last year's program and forms are available at the Community Center for new participants. The Chess Club meets each Friday morning at 10:00 a.m. A request to accept two donations for the month of May in the amounts of \$150 and \$25 was requested. MOTION 04R-10-09 WAS MADE BY JAY ANDOLSHEK AND SECONDED BY RUSTY TAUBERT TO ACCEPT THE DONATIONS OF \$25.00 AND \$150.00 DESIGNATED FOR THE LIBRARY. MOTION CARRIED WITH ALL AYES.

2. PUBLIC SAFETY — Chief Hartman reported 120 calls in Crosslake and 17 calls in Mission Township for March. Approval to hire additional part-time officers was requested. Over the past few months the current part-time officers are being offered positions with other departments making their availability for part-time work difficult. In order to cover this lack of availability, approval to hire additional part-time officers was requested. No additional funding is being requested. MOTION 04R-11-09 WAS MADE BY DEAN SWANSON AND SECONDED BY JOHN MOENGEN TO AUTHORIZE THE HIRING OF PART-TIME OFFICERS IN THE POLICE DEPARTMENT. MOTION CARRIED WITH ALL AYES. North Ambulance reported 37 callouts in March. The Fire Department responded to 6 calls in March for a year-to-date total of 47 calls.

#### 3. PLANNING AND ZONING -

- a. Planning and Zoning Commission/Board of Adjustment Regular Meeting Minutes of February 27, 2009 were included in the packet for Council information.
- b. The March 2009 Permit Summary was included in the packet for Council information.
- c. Included in the packet for Council information was a letter from the Department of Natural Resources which contained details on a possible amendment to rules governing Shoreland Management. A request for comments on the possible amendments opened on January 22, 2008 and the DNR has been engaged in extensive public participation in developing "draft rules" which are open for public comment until 4:30 p.m. on April 17, 2009.
- d. A letter dated March 30, 2009 from DNR Director Kent Lokkesmoe included Permit 2009-0089 authorizing an increase in the run out elevation of the O'Brien Lake outlet structure from 1234.3' to 1234.8'. The addition of 5 inches to the authorized elevation will result in a run out similar to those observed over the last 15 years. The DNR, as owners of the weir crest structure, will make the modification to the structure.
- e. A letter dated March 31, 2009 from resident Terry Curtis requested that the Council consider directing the Planning and Zoning Commission to review the

- allowable use and impact of church development in residential zones. Community Development Director Anderson had his staff put together a table showing the location of churches in other communities and their respective zoning district. Councilmember Roe asked that Staff look at where churches are situated today in Crosslake for review by the Planning and Zoning Commission.
- A request for review and comment on a permit to place shore protection in public waters utilizing clean natural rock underlain by geotextile filter fabric or granular filter bed to follow the existing shoreline alignment all according to plans and specifications designed by the SWCD or the U.S. Natural Resources Conservation Service is open for comments through April 25, 2009. This information was provided as a courtesy to the City for purposes of review and comment. MOTION 04R-12-09 WAS MADE BY JAY BYMOENGEN ANDOLSHEK AND SECONDED JOHN ACKNOWLEDGE RECEIPT OF THE REQUEST FOR REVIEW AND COMMENTS BY THE DNR WHICH ALLOWS COMMENTS UNTIL APRIL 25, 2009. MOTION CARRIED WITH ALL AYES.
- The Planning and Zoning Commission forwarded a request for Council approval of Subdivision 2009-001 for Rush View Preliminary Plat, Fern Gregg Trust/Bruce Larson to the City Council. Approval of the Preliminary Plat was recommended contingent on nine conditions of approval with the inclusion of a Condition No. 10 which would require that a stormwater drainage study be prepared for a minimum five year storm event to determine if a stormwater drainage easement in favor of the City is needed on the north side of the Eagle Street right-of-way. This study would then be reviewed by the City Engineer before final plat approval. The plat would consist of four lots with frontage on Rush Lake all meeting the minimum requirements in lot size and width. It was noted that this property was previously considered for platting under the name "Bear Path" with twelve lots proposed but never completed so is considered null and void. All four lots proposed in "Rush View" will have access via either Eagle Street and/or Anchor Point Road. There will be no access on County Road 66. MOTION 04R-13-09 WAS MADE BY DEAN SWANSON AND SECONDED BY RUSTY TAUBERT TO APPROVE THE PRELIMINARY PLAT FOR RUSH VIEW WITH THE FOLLOWING CONDITIONS: (1.) THE APPLICANT SHALL PAY THE CITY \$15,000 CASH IN LIEU OF LAND FOR PARK DEDICATION WITHIN 90 DAYS OF FINAL PLAT APPROVAL AND PRIOR TO THE SIGNING OF THE FINAL PLAT; (2.) THE CITY SHALL ALL FEES INCURRED AS A REIMBURSED FOR RESULT SERVICES PROVIDED BY THE CITY ATTORNEY, CITY ENGINEER AND CITY SURVEYOR WITHIN 90 DAYS OF SUBDIVISION APPROVAL AND PRIOR TO THE SIGNING OF THE FINAL PLAT; (3.) **MUST FUTURE** DEVELOPMENT COMPLY WITH ORDINANCE REQUIREMENTS; (4.) ALL PROPOSED ALTERATIONS WITHIN THE SHORE IMPACT ZONE SHALL BE CONFINED TO A 15 FOOT ACCESS PATH ON EACH LOT. ALLOTHER LAND ALTERATIONS MUST COMPLY WITH CITY

ORDINANCE REOUIREMENTS AND SHALL REOUIRE ISSUANCE OF AN APPROPRIATE ZONING PERMIT: (5,) A TITLE OPINION OR TITLE INSURANCE COMMITMENT SHALL APPROVED BY THE CITY ATTORNEY PRIOR TO SIGNING THE FINAL PLAT; (6.) NO DRIVEWAY ACCESS SHALL BE ALLOWED TO COUNTY ROAD 66. LOTS SHALL BE ACCESSED OFF OF ANCHOR POINT ROAD AND EAGLE STREET AND CONFORM TO DRIVEWAY SETBACK STANDARDS; (7.) SHOW 10 FOOT DRAINAGE, UTILITY AND PUBLIC USE TRAIL EASEMENTS ALONG ANCHOR POINT ROAD AND COUNTY ROAD 66 AND DRAINAGE AND UTILITY EASEMENTS ALONG ALL ROAD RIGHT-OF-WAYS; (8.) THE PLAT SHALL BE REVISED TO SHOW THE WIDTH OF ANCHOR POINT ROAD, THE WIDTH OF THE ADDITIONAL RIGHT-OF-WAY SHALL BE IDENTIFIED AND THE DEDICATION INCLUDED IN THE FINAL PLAT AND A REVIEW OF THE TITLE AND/OR EASEMENT FOR EAGLE STREET SHALL BE DONE: (9.) LANDFILL AREA CANNOT BE DEVELOPED OR SHOULD BEIDENTIFIED; AND (10.)STORMWATER DRAINAGE STUDY SHALL BE PREPARED FOR A MINIMUM FIVE-YEAR STORM EVENT BY THE APPLICANT TO DETERMINE IF A STORMWATER DRAINAGE EASEMENT IN FAVOR OF THE CITY IS NEEDED ON THE NORTH SIDE OF EAGLE STREET RIGHT-OF-WAY. IT SHALL BE REVIEWED AND, IF NEEDED, APPROVED BY THE CITY ENGINEER BEFORE FINAL PLAT APPROVAL. MOTION CARRIED WITH ALL AYES.

h. A staff report from Community Development Director Anderson contained a request for Council approval of Park Dedication Fees in lieu of land for a metes and bounds Subdivision 2009-003 for Cary and Nikki Shoutz approved by the Planning and Zoning Commission on March 27, 2009. The estimated market value of the subject parcel, according to the Crow Wing County Assessor's Office, is \$136,000. This amount divided by the total number of lots (three) in the plat equals an estimated market value per lot of \$45,333.33. (\$136,000/3 = 45.333.33) This amount times the number of newly created lots of two (2) equals \$90,666.66 of which 10% of adjusted estimated market value equals \$9,066,66. Since this amount falls between the minimum of \$500 per lot/unit and the maximum of \$5,000 per lot allowed by Ordinance, the total cash in lieu of land for park dedication for the two (2) newly created lots is \$9,066.66. At the Public Hearing held on March 27, 2009 there were several comments expressed regarding the amount of park dedication fees being assessed these lots. A summary of the public hearing comments were included in the Staff Report prepared for Council review. After considerable discussion, the Planning and Zoning Commission approved a motion on a 4-1 vote that the City Council considers cash in lieu of land in the amount of \$6,000. At the Park and Recreation/Library Commission Meeting held on April 3, 2009, the Commission reviewed the Shoutz application and reviewed the materials presented to the Planning and Zoning Commission on March 27<sup>th</sup> including the Planning and Zoning Department Staff recommendation. During the Commission Meeting, Director Jon Henke explained the formula

the Ordinance uses to calculate Park Dedication Fees. Mr. Shoutz was present at the Parks and Recreation/Library Commission Meeting and expressed comments that the fee should be lower than what the Ordinance calculates and that the Planning and Zoning Commission recommended an arbitrary amount of \$6,000. Director Henke stated that it was his position that the funding formula laid out in the Ordinance needs to be followed. Shoutz stated that the Planning and Zoning Commission determined their value by eliminating in the calculation the value of the wetlands situated on the property and only calculating useable land. Henke stated that he was not aware of any provision in the Ordinance that would allow for eliminating any of the property in the calculation and that the cash option requires the whole parcel, minus the remnant lot, be utilized to figure the required amount for park dedication purposes. Henke stated that the only way another amount could be calculated would be if the Ordinance was amended and this would take several months to complete since a public hearing would be required by the Planning and Zoning Commission followed by an ordinance amendment City Council review and adoption. Commission Member Alden Hardwick explained to the Commission that their only role was to recommend either cash or land for the subdivision. It is the City Council that makes the decision on the fee, so a motion was unanimously approved to recommend to the City Council that cash in lieu of land be collected for Subdivision 2009-02 for Cary and Nikki Shoutz. On Friday, April 10, 2009, the Planning and Zoning Department Staff received an email along with a copy of a letter dated April 10, 2009 from Attorney Joseph Christensen, who has been retained by Cary and Nikki Shoutz as legal counsel. This letter was presented to the City Council in additions to the agenda presented earlier in the meeting. Based on receipt of this letter, Community Development Director Anderson prepared an additional Staff Report that informed the Council that Mr. and Mrs. Shoutz deposited \$9,066.66 for park dedication fees in escrow with Crow Wing County Abstract Company. They requested that the funds be held pending their appeal of the proposed park dedication fees until the matter is resolved by agreement between them and the City of Crosslake; until their appeal is decided by the District Court; or until they fail to file an appeal within 60 days of the final decision on the subdivision request by the City of Crosslake in which case the funds are to be paid to the City for park dedication fees. Attorney Christensen is recommending that the \$6,000 Park Dedication Fee, recommended by the Planning and Zoning Commission, be approved by the Council. In a Staff Report dated April 13, 2009, Anderson stated three general options available for City Council consideration regarding this request. These options are as follows: (1.) approve the park dedication fee as presented in the Staff Report and as the current ordinance formula calculates in the amount of \$9,066.66; (2.) table action on the park dedication fee to allow the City Council more time to consider the new information presented by the applicant and their legal counsel in the letters received by the City on Friday, April 10, 2009 and received by the City Council at this meeting; or (3.) approve the park dedication fee as recommended by the Planning and Zoning Commission in the amount of \$6,000 and as requested by the

applicant's attorney. It was noted that this is not based upon the current ordinance formula and may be argued to be arbitrary. Although this was not a public hearing, Mayor Andolshek stated that he would allow the applicant, Mr. Shoutz to address the Council. Mr. Shoutz stated that he received a letter from Martyn Schmidt, Crow Wing County Assessor, which changed the estimated market value on the subject property from \$136,000 to \$104,200 due to the 10.9 acres of wetlands situated on this property. This letter from the County Assessor's Office, which was dated April 7, 2009, was in response to a letter postmarked April 6, 2009 from Mr. Shoutz. A quick calculation by City Administrator Swenson resulted in park dedication fees on the revised value of \$104,200 at \$6,933 versus the previously calculated amount of \$9,066.66 on the previous value of \$136,000. Attorney Mike Couri stated that the City Council could use the new value of \$104,000 in calculating the fees but should not use an arbitrary number, therefore would not recommend that the Council consider Anderson's Option Number 3 to approve the \$6,000 amount recommended by the Planning and Zoning Commission. Per Couri, there is no provision in the Ordinance for this so he would recommend that the Council narrow their choices to either Option 1 or Option 2. Attorney Couri commented that the plat could move forward even if the determination on park dedication fees is tabled. Couri did express concern over the Escrow Agreement provided to the Council in that the money in reserve is not solely identified for use in payment of park dedication fees and could be used for other expenses incurred in the closing settlement transaction. Councilmember Roe suggested that the issue go back to the Planning and Zoning Commission for review with the change in market value by the County Assessor's Office. Shoutz stated that there are some legal issues that could arise if the Council doesn't lower his Park Dedication Fee. Shoutz stated that the fee formula does not provide a nexus and does not provide fairness. Shoutz referred to the six requirements listed in Attorney Christensen's letter dated April 10, 2009. Shoutz further stated that the fee is unfair in that he is being charged a 131/2 percent tax on his property containing a ten (10) acre parcel and a seven (7) acre parcel subdivision, whereas a lake property subdivision of two 100 foot lots would only pay \$5,000 per lot. Shoutz stated that he has a closing date set for April 23<sup>rd</sup> and does not want any damages as a result of a problem with closing. Shoutz stated that other individuals wanted to address the Council also, but Mayor Andolshek stated that this was not a public hearing so no additional comments would be allowed from the audience. MOTION 04R-14-09 WAS MADE BY DEAN SWANSON AND SECONDED BY JAY ANDOLSHEK TO TABLE THE PARK DEDICATION FEE ISSUE PROVIDED A PROPER ESCROW AGREEMENT BE PUT IN PLACE FOR THE \$9,066,66 PAYMENT WITH THE CITY'S BEST INTEREST IN MOTION CARRIED 4-1 WITH COUNCILMEMBER ROE VOTING NAY. Attorney Couri stated that he would work with Attorney Christensen and City Staff on the escrow agreement and if all parties can't agree, he will bring the issue back to the Council for resolution.

i. The Planning and Zoning Commission has reviewed the need to consider revised language in the Ordinance as it pertains to regulating lighting within

the City particularly on properties fronting on lakes. Words such as shielded or screened have been added to the proposed ordinance for clarification. Although the current ordinance already requires lighting to be directed downward, several complaints have been received on properties with nonconforming yard lights and flood and spotlights directed towards the water that create glare problems for other property owners. A section of language was added to the proposed ordinance for lighting for and within riparian lots of residential and commercial zoned property as well as a section for lighting within residential zoned property. It was the intent of the Commission to clarify the existing language and show what's permitted and prohibited. Community Development Director Anderson showed photos of various types of lighting. Mayor Andolshek asked what happens to existing properties who would be in violation if the Ordinance is approved and Attorney Couri stated they would be grandfathered in. However, if the light is discontinued for one year they would lose the grandfather status. Councilmember Moengen asked how many complaints have been received and Anderson stated there are currently three complaints that Staff is dealing with. Moengen asked if the mercury vapor lights that Crow Wing Power installs would meet the Ordinance requirement and suggested the Ordinance Amendment be sent to them for review. Mayor Andolshek also expressed concern as to whether they could meet the new standard. After considerable discussion, it was agreed to continue the discussion in May after Staff has received input from Crow Wing Power and some area electrical contractors.

The Planning and Zoning Commission initiated an ordinance amendment to add to the fee schedules for Chapter 3 and Chapter 8, the authority to collect unpaid charges and fees by certifying these costs as unpaid service charges or assessments to the Crow Wing County Auditor for collection on the following MOTION 04R-15-09 WAS MADE BY JAY ANDOLSHEK years taxes. AND SECONDED BY RUSTY TAUBERT TO APPROVE ORDINANCE AMENDMENT NO. 276 AMENDING CHAPTER 3 AND CHAPTER 8, SECTION 8.6 AMENDING THE FEE SCHEDULE TO INCLUDE CERTIFICATION OF UNPAID CHARGES. MOTION CARRIED WITH ALL AYES. Council approval on publishing a summary of Ordinance No. 276 was requested. MOTION 04R-16-09 WAS MADE BY JAY ANDOLSHEK AND SECONDED BY STEVE ROE TO AUTHORIZE THE PUBLISHING OF A SUMMARY FOR ORDINANCE AMENDMENT NO. 276. MOTION CARRIED WITH ALL AYES.

#### 4. CROSSLAKE COMMUNICATIONS –

- a. Crosslake Communication's Bills for Approval <u>MOTION 04R-17-09 WAS MADE BY RUSTY TAUBERT AND SECONDED BY STEVE ROE TO APPROVE THE FEBRUARY 2009 BILLS FOR PAYMENT AS SUBMITTED IN THE AMOUNT OF \$250,358.02. MOTION CARRIED WITH ALL AYES.</u>
- b. The Highlights Report for March was included in the packet for Council review. Paul Hoge reported that Cyndi Perkins was presented with an award at a recent Advisory Board meeting for her five years of service. The

Advisory Board did approve the transfer of funds from the Merrill Lynch account to the 4M Fund as advised by auditors Olson Thielen. The next "Meet the Manager" session has been scheduled for April 16<sup>th</sup> at 9:00 a.m. at the Community Center. Interested persons can find out about products and services offered at Crosslake Communications. Hoge presented an update on the tower expansion and stated that review by the FAA is still in progress. The AT&T Contract has been sent back to AT&T after they recommended a few changes be made. After the audit review by Olson Thielen a letter was sent to the City Council that included a recommendation on the amount of funds that can be paid to the City in 2010 as an operating transfer. The maximum amount of operating transfer in 2010 is \$282,927, which is 8% of gross revenues. The next IBEW Union Negotiation meeting is scheduled for April 20<sup>th</sup> at 10:00 a.m. at City Hall.

MOTION CARRIED WITH ALL AYES. Strand informed the Council that the annual Lions Cleanup Day is scheduled for Saturday, April 25<sup>th</sup>. In May, Staff will do cemetery cleanup for Memorial Day. An ad will be published in the Northland Press and posted on Channel 12.

NOW THEREFORE BE IT HEREBY RESOLVED, that the Crosslake City Council enthusiastically supports the efforts of Crow Wing County to obtain Federal High Priority Project Funding to correct the dangerous road conditions that currently exist on CSAH 36 between CSAH 37 and TH 6.

BE IT FURTHER RESOLVED, that the Crosslake City Council requests consideration be given in the reconstruction design to include paved shoulders for a multi use pedestrian and bike trail to alleviate the extremely unsafe conditions which currently exist for pedestrians and bikers.
