Also present was Reporter Christine DuFour, Former Mayor Dave Kolesar, Mary Kolesar, Jane Michaud, Jack Webster, Dean Swanson and Acting City Clerk Darlene Roach taking the minutes.

Mayor Scott called the meeting to order at 1:00 P.M. by stating that the purpose of the meeting was to interview four candidates for the position of City Administrator.

An interview committee consisting of Ray Smyth, Jane Michaud, County Commissioner Jim Hill and Mayor Scott had narrowed the selection from 19 candidates to four. The individuals invited back for a second interview were Thomas Swenson, City Administrator in Hawley; Thomas MacAulay, Assistant City Administrator in New Ulm; Michael Mills, Program Support Manager for United Defense; and Diane Roghair, Business Analyst with Bankers System in St. Cloud. Each of the four candidates was allowed an hour for the interview.

The meeting was turned over to Councilmember Ray Smyth to begin the interview process. As each candidate arrived at their scheduled time for their interview, they were introduced to each member of the Council and to those in the audience. Each candidate was given the procedure for the interview. Each candidate started the interview by describing their education qualifications and background experience. Each member of the Council then presented a series of prepared questions to ask each candidate. The audience was also invited to ask any questions they felt pertinent. At the end of each interview, the candidate was allowed time to ask questions of the Council.

Upon conclusion of the interviews, each member of the Council ranked the various candidates and Mayor Scott tallied the results. Mr. Thomas Swenson was the ranked as the top candidate for the position with Mr. MacAulay being second.
