

COUNCIL PROCEEDINGS
CITY OF CROSSLAKE MINNESOTA
PUBLIC HEARING
JUNE 8, 1990

The City Council for the City of Crosslake met in a Public Hearing on Friday, June 8, 1990 in the Council Chambers of City Hall. The following Councilmembers were present: Acting Mayor Diana A. Gallaway, Lyle M. Arends, Roger A. Burshem and Charles O. Miller. Also present were Will Hoyt, Engineer, from Landecker and Associates, Inc., City Clerk Arlene A. Buchite and approximately 23 residents of the community.

Acting Mayor Gallaway called this meeting to order at 8:00 p.m. and welcomed everyone present. Ms. Gallaway stated that the primary purpose of this Public Hearing was to hear the results of the card survey for blacktopping Rushmore Boulevard and then turned the meeting over to Will Hoyt.

Mr. Hoyt explained to those present that there had been a Public Hearing on April 27, 1990 regarding the blacktopping of Rushmore Boulevard and at that hearing the Council voted to table the project and if the proponents wanted to come in with a new survey the Council would reconsider it at that time.

The estimated cost per lot would remain at \$1,440, according to Mr. Hoyt. Mr. Hoyt read into the record three letters which had been received by the City Clerk. Mr. Hoyt also read the respondents name and any comments which had been returned with the card survey which had been conducted by the proponents of the blacktopping issue.

Several residents spoke with some in favor and some against the blacktopping.

In response to a question regarding payment of the assessment Mr. Hoyt stated that it would be up to the Council but typically it has been no interest if paid in full within 30 days after the final assessment hearing or a seven year assessment paid annually along with real estate taxes with the interest set at 8 3/4 percent.

It was the consensus of those residents present that they be notified if the bid is substantially larger than the estimate. Mr. Hoyt indicated that he was quite sure the Council would not have a problem with that. Mr. Hoyt stated that they would like to have the Council set the bid date at the regular council meeting in July.

Member Miller said he could sympathize with the residents who have a problem with the dust because he is the only one with a

car on his road and he does not like the dust on his road and with the vote at 18 in favor, 13 against and one no vote he wanted to make a motion to proceed.

MOTION NO. 6PH-01-90 WAS MADE BY MEMBER MILLER AND SECONDED BY MEMBER BURSHAM TO PROCEED WITH THE BLACKTOPPING OF RUSHMORE BOULEVARD AND IF THE COSTS EXCEED THE ESTIMATES BY 10 PERCENT, ALL PROPERTY OWNERS WILL BE NOTIFIED BEFORE CONSTRUCTION. UPON ROLL CALL VOTE MEMBERS ARENDS, BURSHAM, GALLAWAY AND MILLER VOTED AYE. MOTION PASSED.

A complete copy of the tape of this meeting is on file in the City Clerk's office.

Acting Mayor Gallaway stated that the next item on the agenda would be the review of the Garbage Haulers ordinance. Ms. Gallaway read a letter from City Attorney James Gammello stating that he felt the licensing should be left to the County as long as they already license the haulers and that way there would be less liability for the City.

MOTION NO. 6PH-02-90 WAS MADE BY MEMBER MILLER AND SECONDED BY MEMBER ARENDS TO RESCIND GARBAGE AND REFUSE HAULERS ORDINANCE 5.22 OF THE CITY CODE BOOK. MOTION PASSED WITH MEMBERS ARENDS, BURSHAM AND MILLER VOTING AYE.

Acting Mayor Gallaway explained to the Council that City Attorney Gammello had sent 2 different revisions to the Council for their consideration regarding the surety bond requirements for liquor licensing. The State of Minnesota no longer required bonding and the City Council voted at the regular meeting on May 14, 1990 to go along with the State. One of the amendments was to eliminate the bonding and the second amendment was that the applicant could file a bond if he wanted to.

MOTION NO. 6PH-03-90 WAS MADE BY MEMBER ARENDS AND SECONDED BY MEMBER MILLER TO DROP THE BONDING REQUIREMENTS FOR LIQUOR LICENSING BY ACCEPTING OPTION NO. 1 WHICH REPEALS SUBDIVISION 1 OF SECTION 4.32 OF THE CITY CODE BOOK. MOTION PASSED WITH MEMBERS ARENDS, BURSHAM AND MILLER VOTING AYE.

MOTION NO. 6PH-04-90 WAS MADE BY MEMBER MILLER AND SECONDED BY MEMBER BURSHAM TO ADJOURN THIS PUBLIC HEARING AT 8:55 P.M. MOTION PASSED WITH MEMBERS ARENDS, BURSHAM AND MILLER VOTING AYE.
