





TRAINING

Training remains a cornerstone of the Crosslake Fire Department's commitment to safety, professionalism, and operational excellence. Over the past year, our members contributed a total of 2,819 training hours, meeting and exceeding NFPA standards and Minnesota Board of Firefighter Training and Education (MBFTE) guidelines. This dedication ensures our firefighters maintain the knowledge, skills, and certifications necessary to serve our communities effectively.

In addition to in-house instruction, the department participated in cross-department training, strengthening regional cooperation and interoperability. These joint exercises included pumping operations scenarios and tactical EMS training, allowing members to practice real-world response techniques while building strong working relationships with neighboring departments.






FIRE PREVENTION & LIFE SAFETY

Fire prevention efforts in 2025 included the first full year of Short-Term Rental life safety inspections. These inspections focused on smoke alarms, carbon monoxide detection, emergency exits, and overall compliance with safety standards. The program was successfully implemented and contributed to improved safety for residents and visitors.

EMERGENCY MANAGEMENT

A major achievement in 2025 was the completion of the City of Crosslake Emergency Operations Plan (EOP). The plan provides guidance for coordinated response to a wide range of emergency scenarios, including natural disasters, severe weather events, and other large-scale incidents.

This effort was supported by a \$5,000 grant from the Initiative Foundation for disaster preparedness and recovery. In early 2026, the department plans to review the EOP with elected officials and department heads and conduct a tabletop exercise to evaluate response coordination and identify areas for improvement.

The department made several infrastructure and equipment improvements in 2025 aimed at enhancing readiness and protecting assets. Three additional outdoor warning sirens were installed, improving emergency alert coverage throughout the city.

STAFFING & RECRUITMENT

Staffing and recruitment remain essential to the continued strength and readiness of the Crosslake Fire Department. Building and maintaining a dedicated, skilled, and diverse membership ensures our ability to provide reliable emergency services now and into the future.

As part of our ongoing recruitment efforts, the department will host a Women Explore Fire Day in Minnesota this spring, aimed at encouraging more women to consider careers and volunteer opportunities within the fire service. This event will offer hands-on experiences, information on training and certification, and opportunities to connect with current firefighters in a welcoming and supportive environment.

Through targeted outreach, community engagement, and inclusive recruitment initiatives, the Crosslake Fire Department is committed to strengthening our membership and ensuring a capable, professional team ready to serve our communities.

COMMUNITY OUTREACH

Community outreach and public education are essential to reducing risk and building strong relationships. In 2025, the department participated in numerous community events, including Kamp Kimchee, Whitefish at the Lakes Senior Living Complex, Golden Horizons, Camp Knutson, Crosslake Community School activities, National Night Out, the Annual Pig Roast and Car Show, and the first annual Crosslake Fire Department Golf Tournament.

COMMUNITY SUPPORT

The Crosslake Fire Department continues to benefit from generous donations from residents and businesses. These contributions allow the department to purchase equipment and resources not included in the operating budget and directly support firefighter safety and service delivery.

GOALS & PRIORITIES

Looking ahead, the department has identified several key goals and priorities for 2026:

- Onboard and train newly hired firefighters
- Implement and evaluate the Emergency Operations Plan through exercises
- Integrate the new 2,100-gallon tender into service
- Continue expanding training and professional development
- Maintain strong community outreach and public education efforts
- Pursue grant opportunities to support infrastructure and equipment needs

Future Outlook

The Crosslake Fire Department remains committed to continuous improvement and long-term planning. As the community grows and service demands evolve, the department will continue to adapt through training, strategic investment, and collaboration with city leadership and regional partners. The department is proud to serve Crosslake and looks forward to continuing its mission of protecting the community with professionalism, dedication, and pride.
