The matter of the replacement of telephone  
poles as furnished and erected by Dave Robinson

Mr Robinson presented a bill for setting  
and putting wire on 287 poles as the contract  
price of \$99.90 and 33 poles at 35¢ each and  
for extra work installing extra ~~5~~ wires  
and boxing to the amount of \$40.00

A motion of Mr Allen Sec by Eberman it was  
ordered that Watertown's 50% of the bill be paid by  
the Clerk was directed to draw an order to  
Mr Robinson in amount of \$78.50

Chas Aldrich presented a bill of \$6.90 for road  
work which was allowed and warrant drawn

Bills for insulators, wire and brackets for  
the new poles installation wire were presented  
by the Mission Town and the Clerk was instructed  
to draw a warrant for our share 50% in amt  
of \$20.34 this completes the payments in full  
for every item connected with the pole replacement  
job

Bill of Chas Heath for \$12.00 for work on the  
Beekel road was presented and allowed and  
warrant drawn

Bills for fire rental to date were presented  
by Mission Town were presented and payment  
in full in amount of \$128.00 was ordered paid
